Turn Right (South) onto Hwy W (Port Washington Road) travel 1 block to the first stoplight (Schmit's Pavilion). Turn Right into Schmit's Pavilion. WVRC is the Southern most unit in the Pavilion next to the Baymont Inn.

Each dog will be given 3 minutes on the dock. If a try-it or competing dog wishes to have more time, they may purchase more tickets as timing allows.

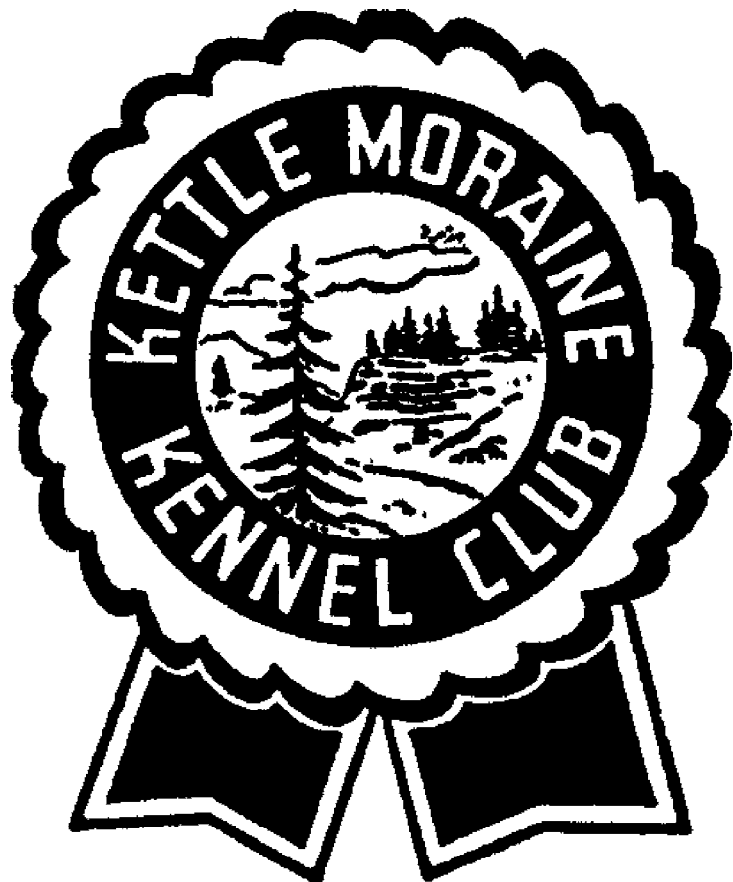
