Amateur Gun Dog is a retrieving stake with call backs for the retrieve.

COURSES AND BIRDS

All stakes single course. Horseback handling will be allowed in all stakes. No wrangler horses will be provided. All Stakes will have Quail released. Gunshots will be required in all stakes.

NOTE: Only blank guns with solidly filled barrels will be permitted.

AKC approved tracking collars allowed, but not provided.

Entries withdrawn after the draw will NOT be refunded unless a bitch is in season or a dog is injured. An injured dog must have a note from a veterinarian to receive a full refund.

The CWVC reserves the right to cancel the Trial due to inclement weather. If the trial is cancelled by the CWVC, full refunds will be given.
