COURSES AND BIRDS

All stakes single course. Horseback handling will be allowed in all stakes. <u>No wrangler horses will be provided.</u> All Stakes will have Quail released. Gunshots will be required in all stakes.

NOTE: Only blank guns with solidly filled barrels will be permitted.

AKC approved tracking collars allowed, but not provided.

Entries withdrawn after the draw will NOT be refunded unless a bitch is in season or a dog is injured. An injured dog must have a note from a veterinarian to receive a full refund.

The CWVC reserves the right to cancel the Trial due to inclement weather. If the trial is cancelled by the CWVC, full refunds will be given.
